Snowperformance Booking Policies

A registration form must be received for each person attending any camp to secure a place on that camp. Any person signing the registration form on behalf of others guarantees payment of the full cost of the camp of all those mentioned on the form and for any others added at a later date.

Deposit

A deposit shall be paid in advance of any camp and shall be forfeit in the case of cancellation. The cost of the deposit will be 20% or a named amount of each camps total cost.

Balance of payment

Shall be paid within ten weeks of any foreign trip and within 4 weeks of any camp within the US. Should the balance not be paid by the due dates we reserve the rights to cancel the booking and levy cancellation charges as laid out below.

Cancellations

The deposit will be forfeited in all cases and depending on the timing of when the cancellation is sent in writing the following charges expressed as a % of the total camp cost shall be made.

Foreign camps

More than 10 weeks Deposit

Within 10 weeks 35%

Within 5 weeks 50%

Within 2 weeks 100%

Camp date or after 100%

US camps

More than 10 weeks Deposit

Within 4 weeks 35%

Within 3 weeks 50%

Within 2 weeks 100%

Camp date or after 100%

All cancellations must be notified to us in writing by the person who signed the registration form. If no written notice of cancellation is received and you do not attend the camp, cancellation shall be deemed to be the day of the start of the camp. We reserve the right to resell the camp to others and this does not affect our right to levy cancellation fees. Please note that you may make a claim against your insurance company if the reason for cancellation falls within their policy, but that cancellation charges must be paid to us then reclaimed by you from your insurance company.

A cancellation Invoice can be sent to the person who made the booking.

Snowperformance reserves the right to cancel any camp, due to poor snow, low participation or other reasons and in these cases will refund in full any person who has paid a deposit or full payment. We also reserve the right to refuse participation in our camps to any individual or group.

Insurance

It is a condition that all clients of Snowperformance that book a foreign camp with Snowperformance get covered by a personal vacation insurance policy covering them for the duration of the camp and all travel related arrangements. Cancellation Insurance can be got on all camps.
